When will long-term contracts for energy storage projects be released?

The exact release date for the Long-Term Contracts for Energy Storage Projects remains "TBD," though a tentative schedule in the draft suggests a public release of the RFP on July 31, 2025. The RFP includes scheduled periods for questions and feedback through the fall, with proposal submissions due by Sept. 10.

What is the energy storage initiative?

The Governor launched the Energy Storage Initiative in May 2015, with the goal of advancing the energy storage segment of the Massachusetts clean energy industry by: Recommending and developing policies, regulations and programs that help achieve those objectives.

How much does a long-term storage project cost?

Upon executing long-term storage contracts, developers must provide a security deposit of \$40,000 per MW, totaling up to \$60 million. With estimated costs around \$200/kWh, total project value could range from \$2.8 billion to \$7 billion, depending on the chosen storage capacities.

How many MWh will energy storage be achieved by 2025?

The Act established a 1,000 MWh energy storage target to be achieved by December 31, 2025. The Act requires each electric distribution company annually report energy storage installations in their territory no later than February 15. Progress
