On June 10,2021,the 29th meeting of the Standing Committee of the 13th National People's Congress passed the Hainan Free Trade Port Law of the People's Republic of China,which determined to establish and improve the Hainan Free Trade Port customs supervision special zone systemwith closed-off customs operations on the entire island.

With a zero-tariff system fundamentally in place after the independent customs operation, high-quality global resources can flow into Hainan with greater freedom and efficiency, Wu said. Trade liberalization and facilitation are defining features of a free trade port.
