Does Slovenia have gas storage facilities?

Slovenia does not have gas storage facilities, and is dependent on infrastructure in Austria and Croatia. Slovenia has expressed interest in securing U.S. LNG sources via terminals in Krk, Croatia, or Rovigo, Italy, to diversify its supply. Beginning in 2027, Geoplin booked additional capacity to acquire LNG from the Krk terminal.

Does Slovenia have a natural gas supply contract with Gazprom?

The state-owned gas company Geoplin signed a five-year natural gas supply contract with Gazprom in 2018 to import 600 million cubic meters of Russian natural gas per year. Russia's February 2022 invasion of Ukraine, however, forced Slovenia to reconsider its energy policy and seek alternate sources.
